***Superintendent will determine how many, and what size cages are needed according to number and breed of birds exhibited.***

**Guidelines the Superintendent will follow:**

1. Each Cloverbud/Pee Wee bantam chicken or bantam duck will have their own cage.
2. Never put two cocks or two cockerels together.
3. Cock/hens and cockerel/pullets of the same breed will share one cage (whether shown as a pair or as individuals).
4. Any two hens or two pullets will share one cage (whether same breed or not).
5. Any two market entries of the same species will share one cage, with the exception of two Tom Turkeys.
6. All breed pairs will share one cage.
7. Hen and chicks will be given cages with smaller wire so the chicks don't get out.
8. Exceptions to these guidelines will be addressed on check-in / entry day based on large bird size, available cage space, and tendency of birds to fight.
