

# Parent and Exhibitor PEF Form



In order to prevent the spread of COVID-19 throughout the duration of the Cass County Youth Show & Go, the 2020 Show & Go will be spectator free. The following are the requirements for entrance onto the premises:

- Waiver of liability and hold harmless form must be signed by a parent and/or guardian of the exhibitor(s) listed on the Patron Entrance Form (PEF).
- A new/separate PEF form needs to be submitted, at the entrance gate, for each species/day that an exhibitor is exhibiting.
- Read and understand the all rules and guidelines for the 2020 Show & Go including the additional rules listed with this form.
- We strongly encourage families to travel together.
- Temperature screening at check in (anyone with temperature 100.4 or over will not be permitted to enter.)
- Each person entering a show will be given a wrist band at the entrance gate. (after completing the temperature scan, PEF form and the Waiver of Liability and Hold Harmless Agreement)
- Governor Whitmer ordered that everyone must wear a mask. / Exhibitor's do not have to wear a mask while showing.
- Social Distancing must be followed
- No strollers, car seats, back packs in animal areas
- Babies will be considered as one of the number of people entering through the gate (if you are bringing a baby, they will be considered one of the 2 people.

## WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

In consideration for receiving permission to be on premises at Cass County Fairgrounds for the 2020 Cass County Youth Show & Go (2020 Show & Go), I, on behalf of myself and any minor child/children for whom I have the capacity to contract, as well as any other individuals listed on the signed "Patron Entrance Form" for our family, hereby acknowledge and agree to the following:

1. I understand the hazards of the novel coronavirus ("COVID 19") and am familiar with the Centers for Disease Control and Prevention ("CDC") guidelines regarding COVID-19. I acknowledge and understand that the circumstances regarding COVID-19 are changing from day to day and that, accordingly, the CDC guidelines are regularly modified and updated and I accept full responsibility for familiarizing myself with the most recent updates.
2. Notwithstanding the risks associated with COVID-19, which I readily acknowledge, I hereby willingly choose to participate in the 2020 Show & Go event.
3. I will utilize all safety precautions suggested by the Cass County Fairgrounds, the Cass County Fair Board of Directors, and the CDC guidelines.
4. I acknowledge and fully assume the risk of illness or death related to COVID-19 arising from my being on the premises and hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE (on behalf of myself and any minor children for whom I have the capacity to contract as well as those I have listed on the "Patron Entrance Form") Cass County Fairgrounds, their owners, officers, directors, agents, employees and assigns (the "RELEASEES") from any liability related to COVID-19 which might occur as a result of my being on the premises and participating in the activities.
5. I shall indemnify, defend and hold harmless the RELEASEES from and against any and all claims, demands, suits, judgments, losses or expenses of any nature whatsoever (including, without limitation, attorneys' fees, cost and disbursements, whether of in-house or outside counsel and whether or not an action is brought, on appeal or otherwise), arising from or out of, or relating to, directly or indirectly, the infection of COVID-19 or any other illness or injury.

It is my express intent that the Waiver and Hold Harmless Agreement shall bind any assigns, heirs, and representatives, and shall be deemed as a RELEASE, WAIVER, DISCHARGE, AND COVENANT NOT TO SUE the above-named RELEASEES. This Agreement and the provisions contained herein shall be construed, interpreted, and controlled according to the laws of the State of Michigan. I ACKNOWLEDGE THAT THIS WAIVER WAS EXPRESSLY NEGOTIATED AND IS A MATERIAL INDUCEMENT OF THE PERMISSION GRANTED BY RELEASEES TO BE ON PREMISES.
