Cass County Fair General Campground Rules and Regulations



It is the registered Campers responsibility to review these Rules and Regulations and share them with everyone on their campsite.

*By accepting and paying for a Campsite, all Campers agree to abide by all rules and regulations as printed and thoroughly outlined as follow.

Check In /Out Times

Check in time will be Friday October 7, 2022 - 2:00 P.M. - 7:00 P.M.

Check out will be Sunday October 9, 2022- by 3:00 P.M.

Electric

The Cass County Fair Association is not responsible for any electrical service over 30 amperes for campers.

Gray Water

State Law prohibits the discharge of gray water or black water(sewer) on the ground or stored in containers. All gray water and black water must be dumped in our dump stations.

Trash & Clean-up

Keep grounds neat and clean around camper. Trash receptacles (barrels) will not be placed in the camping area and should not be moved there.

Campers are responsible for disposal of trash in designated dumpster containers.

Absolutely NO burning of Trash

Quiet Hours

Quiet hours 11:00 p.m.-7:00 a.m. Any camper or campers may be asked to leave for being disorderly.

Campfires

Campfires must be contained in above ground fire pit

No campfires are to be left unattended and must be extinguished before retiring or leaving the site.

Pet Policy

Limit of no more than 2 pets per site.

All pets must be leashed with no more than a 6' leash, cleaned up after and attended to at all times.

Pets may NOT be vicious or excessive barking and may be asked to leave.

Pets are not to be left unattended, tied, or caged outside your camper.

Motorized Vehicles

Motorized vehicles/ scooter/ gators/ golf carts/ atv's /etc. are PROHIBITED

Bikes are allowed in designated areas/ NOT in barns or buildings and must be back at your site by dusk.

Occupancy/ Visitors

State Law requires no more than 8 Individuals on a site.

Children under 18 cannot be left alone overnight to occupy the campsite without adult supervision.

Parents are responsible for the safety and behavior of their children, friends of their children and guests at all times.

Restrooms and Showers

Restrooms and Shower's will be available

Indemnity

The use of facilities and Campgrounds by any person is at the person's risk and registered Camper agrees to indemnity and hold harmless from any loss, cost or damage incurred by it as a result of the activities of the registered Camper, his or her family members, visitors, or guests. You further agree to release Cass County Fair, its employees, officer, owners, directors, and agents harmless from all claims and costs. You further agree to indemnify and hold the listed harmless from all claims and costs made by minors who are in your custody, guests, and all other persons in your group ABSOLUTELY NO FIREWORKS ALLOWED!!!
